

# SaskEnergy Paperless Billing Contest

## February 1, 2017 to March 31, 2017

### OFFICIAL RULES AND REGULATIONS

#### General

1. SaskEnergy Incorporated (the "Contest Sponsor") is sponsoring the SASKENERGY PAPERLESS BILLING CONTEST (the "Contest"). The Contest begins on February 1, 2017 and will close on March 31 at 11:59:59 p.m. CST (the "Closing Date").
2. By entering this Contest the entrants automatically agree to accept and abide by these rules and regulations (the "Contest Rules"). All decisions of the Contest Sponsor with respect to any aspect of this Contest, including without limitation the eligibility of entries, are final and binding on all entrants in all matters as they relate to this Contest.

#### Eligibility

3. Participation in the Contest is limited to residents of the Province of Saskatchewan who are 16 years of age or older at the time of entry. Employees and their spouses, parents, siblings and children, and persons domiciled with an employee, of the Contest Sponsor, or any company controlled by Contest Sponsor, or a subsidiary or division of Corporate Sponsor, are ineligible to win. The Contest is void outside the province of Saskatchewan.
4. By entering the Contest, each entrant consents to the use of his or her name and city/town of residence without compensation in any publicity or advertising carried out in any medium worldwide by the Contest Sponsor and/or their advertising or promotional agencies without limitation or further notification or compensation.

#### How to Enter

5. No purchase necessary. All eligible entries will be entered in a random draw. Only one (1) entry per SaskEnergy account is allowed, or, if you do not have a SaskEnergy account and the entry is mailed in, only one (1) mail-in entry per household will be allowed. In the event it is discovered that you attempted to enter more than allowed, all of your entries will be void. The Contest can be entered by one of the following methods: You will be entered:
  - a. automatically if you have signed up your SaskEnergy account for the paperless billing option as of the Closing Date; or
  - b. upon the Contest Sponsor receiving an entry by mail addressed to SaskEnergy, Customer Solutions, 800-1777 Victoria Ave, Regina, SK, S4P 4K5 with the entry consisting of a piece of paper that includes your name, age, address, daytime phone number, AIR MILES® Collector Number and "SaskEnergy Paperless Billing Contest entry" indicated on the outside of the envelope. Mail-in entries must be postmarked on or before the Closing Date (facsimile or e-mail entries not accepted).
6. The Contest Sponsor is not responsible for entries that are incomplete, illegible, inaudible, damaged, irregular, have been submitted through illicit means, or do not conform to or satisfy any condition of these Contest Rules and all such entries may be disqualified. All entries become the sole property of the Contest Sponsor and none will be returned.

#### Prize

7. One winner will be awarded one prize of 20,000 AIR MILES® Reward Miles (the "AIR MILES® Reward Miles Prize").
8. If the winner is not an AIR MILES® Collector, he/she may enroll in the AIR MILES® Reward Program by visiting [airmiles.ca](http://airmiles.ca). By enrolling to become an AIR MILES® Collector you agree to be bound by the terms and conditions of the AIR MILES® Reward Program as amended from time to time. You must be an AIR MILES® Collector to receive the AIR MILES® Bonus Miles.
9. The approximate retail value of AIR MILES® Reward Miles depends on the chosen method of redemption, available reward options at the time of redemption, and the set preference between AIR MILES® Cash and AIR MILES® Dream balances. If redeemed with AIR MILES® Cash, 95 Reward Miles can be redeemed in-store for \$10 towards purchases at participating AIR MILES® Sponsors or 95 Reward Miles can be redeemed online for eVouchers for \$10 worth of value at participating Reward Partners. If redeemed for flights (1,200 Reward Mile minimum required for

flight redemption), value depends on destination chosen, date of travel and use of multiple carriers or suppliers. For example, one return economy flight in low season departure from Toronto, Ontario to Winnipeg, Manitoba is 2,000 AIR MILES® Reward Miles and has an approximate value of \$525.00 (Canadian) excluding taxes. Winner must pay applicable taxes, related transportation fees, governmental levies, excess baggage and other non-ticket costs. The value of AIR MILES® Reward Miles redeemed for non-flight reward options depends on reward options in effect at the time of redemption. AIR MILES® Reward Miles are subject to the terms and conditions of the AIR MILES® Reward Program as amended from time to time.

10. Prize must be accepted as awarded. Prize may not be sold, transferred and is not convertible to cash. Contest Sponsor reserves the right to substitute the Prize in whole or in part in the event that all or any component of the Prize is unavailable. Prize winner is solely responsible for all costs not expressly described herein.
11. AIR MILES® Reward Miles Prize Details: AIR MILES® Reward Miles Prize will be posted directly into the AIR MILES® Collector Account of the confirmed winner six to eight weeks after the random drawing. To ensure that the winner receives the Prize in his or her preferred balance, winner should ensure his or her balance preferences (AIR MILES® Cash balance and AIR MILES® Dream balance) are set as desired prior to the Prize being posted in his/her Collector Account.
12. If a potential winner of AIR MILES® Reward Miles is not an AIR MILES® Collector, he/she may enroll in the AIR MILES® Reward Program by visiting [airmiles.ca](http://airmiles.ca). By enrolling to become an AIR MILES® Collector you agree to be bound by the terms and conditions of the AIR MILES® Reward Program as amended from time to time.
13. Odds of winning depend on the number of eligible entries received.

#### **The Draw**

14. On Tuesday, April 4, 2017 in Regina, SK, at 11:00 am CST, a random draw will be conducted by SaskEnergy from all eligible entries received through all eligible entry methods to select a potential winner of the Prize (the "Draw").
15. The selected entrant will be notified by telephone within approximately three (3) business days of the Draw ("Notification"). The Contest Sponsor assumes no responsibility for any inaccurate or incorrect information provided to it, or that results in any way from the transmission, receipt or processing of entries. If the first selected entrant does not respond within three (3) days of first contact, the Contest Sponsor will have the right to disqualify that entrant and to randomly draw another eligible entry. By entering, you agree that if you are a selected entrant that is disqualified or the Prize is forfeited for any reason, the Contest Sponsor will be fully and completely released and discharged from any liability or responsibility in this regard. Contest Sponsor is not responsible for the failure for any reason whatsoever of a selected entrant to receive Notification.
16. Upon Notification, the selected entrant must, unaided, correctly answer a time-limited mathematical skill-testing question. In the event that a selected entrant is unable to answer the skill-testing question correctly, the Contest Sponsor will have the right to disqualify said entrant and to randomly draw another eligible entry, and the Contest Sponsor shall be fully and completely released and discharged from any liability or responsibility in this regard.
17. If a selected entrant is not eligible or does not otherwise meet the requirements as set out in the Contest Rules, the Contest Sponsor will have the right to disqualify said entrant and randomly draw another eligible entry for purposes of awarding the Prize, and the Contest Sponsor shall be fully and completely released and discharged from any liability or responsibility in this regard.

#### **General Conditions**

By entering the Contest, entrants and selected entrants agree to release and hold harmless the Contest Sponsor, LoyaltyOne, Co. and their directors, employees, officers, agents and affiliates from any injury, loss or damage of any kind to persons or property, including but not limited to death, resulting in whole or in part directly or indirectly from the acceptance, receipt, possession, use or misuse of an awarded prize, participation in any Contest-related activity including any travel related thereto and/or participation in the Contest.
19. By entering the Contest, each selected entrant agrees to sign and return the following to SaskEnergy within fourteen (14) days of Notification:

A liability release form releasing the Contest Sponsor, LoyaltyOne, Co., their directors, employees, officers, agents and affiliates from all liability arising from or relating to the acceptance, receipt, possession, use or misuse of an awarded prize, participation in any Contest-related activity including any travel related thereto and/or participation in this Contest; and
  - c. A publicity release and consent form permitting the Contest Sponsor to use his or her name and city/town of residence without compensation in any publicity or advertising carried out in any medium worldwide by the Contest Sponsor and/or its advertising or promotional agencies without limitation or further notification, unless prohibited by law. If the selected entrant fails to submit the above within the given time period, the Contest Sponsor reserves the right to disqualify said entrant and randomly draw another eligible entry for the purpose of awarding the Prize (time permitting), and the Contest Sponsor shall be fully and completely released and discharged from any liability or responsibility in this regard.

  21. The Contest Sponsor will not be liable for any human or technical errors that may arise or occur in connection with the Contest. The Contest Sponsor assumes no responsibility for any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft or destruction or unauthorized access to, or alteration of the entries.
  22. No correspondence will be entered into except with entrants requesting the Contest Rules by mail or requesting the name of the Prize winner (for which a self-addressed, postage paid envelope must be included).
  23. The Contest Sponsor is not responsible for any problems or technical malfunction of any telephone network or lines, computer online systems, servers or providers, computer equipment, software, failure of any e-mail or entry to be received by the Contest Sponsor as a result of technical problems or human error, or any combination thereof.
  24. The Contest Sponsor reserves the right at its sole discretion to disqualify any individual who tampers with or attempts to tamper with the entry process. ANY ATTEMPT BY AN ENTRANT TO DELIBERATELY UNDERMINE THE LEGITIMATE OPERATION OF THE CONTEST MAY BE A VIOLATION OF CRIMINAL AND CIVIL LAWS AND SHOULD SUCH AN ATTEMPT BE MADE, THE CONTEST SPONSOR RESERVES THE RIGHT TO SEEK DAMAGES FROM ANY SUCH ENTRANT TO THE FULLEST EXTENT PERMITTED BY LAW INCLUDING CRIMINAL PROSECUTION.
  25. This Contest is governed by the laws of Saskatchewan and the laws of Canada applicable therein, and is subject to all applicable federal, provincial and municipal laws and regulations.
  26. By entering this Contest, the entrant agrees that the courts of the Province of Saskatchewan, Canada shall have jurisdiction to entertain any action or other legal proceedings based on any provision of the Contest Rules or the running of this Contest. The entrant hereby irrevocably attorns to the exclusive jurisdiction of the courts of the Province of Saskatchewan.
  27. The Contest is managed by SaskEnergy Incorporated. LoyaltyOne, Co. is in no way connected to the management of the Contest.
  28. THE CONTEST SPONSOR IS COLLECTING PERSONAL INFORMATION ABOUT ENTRANTS FOR THE SOLE PURPOSE OF ADMINISTERING THIS CONTEST UNLESS OTHERWISE PROVIDED FOR BY THE CONTEST RULES. Contest Sponsor will not sell or transmit this information to third parties except for the purposes of administering this Contest.
